

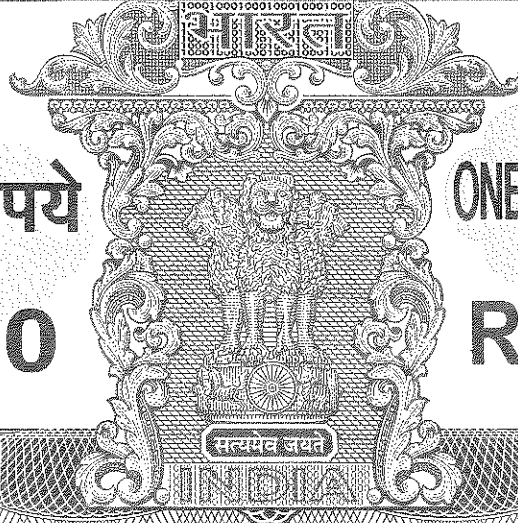

AGREEMENT FOR VEHICLE HIRING


This agreement is made on this 8th Day of February, 2019 at Patna between M/s Sampurna Enterprises ("the Service Provider"), a sole proprietorship concern having its headquarter at 8-Commercial Building (1st Floor), North – West Corner of S.K. Puri Children's Park, Behind Tapasya Complex, Boring Road, Patna-800001 and represented by its sole proprietor Mr. Rakesh Prakash (hereinafter referred to as the first party or the firm which expression shall include his heirs, executors and successors) and Bihar Gram Swaraj Yojna Society (BGSYS) ("the Client") having its principal place of business at 3RD Floor, Biscomaun Tower, Gandhi Maidan, -800001 (hereinafter referred to as the second party and to include all his successors and assigns) for supply of vehicles on monthly/daily basis (As and when required basis) on the following terms and conditions:

1. All the vehicles to be supplied should have a proper registration with the Transport Department, Govt. of Bihar.
2. The first party / agency will comply with all legal liability related to RTO and the vehicle.
3. The vehicles to be supplied should not have a registration older than 2015 and all of them should be in good condition.
4. Maintenance of the vehicles, fuel and Driver's salary will be responsibility of the first party / agency.

5. In case of accident, the liabilities towards vehicle and driver will be that of the supplying firm / first party.
6. Vehicles are to be made available on all seven days of the week.
7. All vehicles will be duly insured along with required insurance coverage.
8. In case of break in the service there will be deduction from the Bill/Invoice of the firm. Such deduction will be in the same proportion of Monthly rental payable. Additionally, **Rupees 500/-** per day will also be deducted from firm's claim as penalty for all such days when there was breakage in the service.
9. The above mentioned firms (M/s Sampurna Enterprises) will have to make available any number of vehicle within the stipulated time that may be asked by the department.

Validity of the Contract: As per the Tender document, this contract will normally be valid for a year or upto the closure of the project (whichever is earlier). The commencement of service should be started within 5 days from the date of agreement. However, the contract may be mutually extended for another one year in case if the service of the above said firm (M/s Sampurna Enterprises) is found to be satisfactory during this period.

Special Condition: The type of vehicles and services which is not covered under the contour of this agreement. In this scenario, rates shall be taken from the "Bihar State Tourism Development Corporation Ltd. (BSTDC)" for hiring of such services from the vehicle provider agency (first party) or any of the vehicle provider from the open market.

Rate of Hiring of the Vehicle: The rates for Hiring different kind of vehicle on Daily / Monthly basis will be as under (as per the approved rate):

Contact person: SPM (Admin) will be the contract person for the assignment related to this agreement. Normally 2-3 days prior intimation will be given for providing the vehicle on daily basis.

Mode of Payment:

The firms providing the monthly vehicles (i.e. M/s Sampurna Enterprises) will raise its Invoice/Invoices on monthly basis preferably by 5th day of each following month and the BGSYS will ensure payment to the firms within 10 days of receipt of the bill/invoice along with signed log book from BGSYS officials.

In case of vehicles hired on daily basis, the firm can raise bills along with signed log book/Duty slip from BGSYS officials on weekly basis and in such cases the BGSYS will ensure payment against all such bills within 15 days of receiving the bills.

However If the services has not been provided within the stipulated time frame, the required vehicle may be hired from any other vendor / service provider at the same approved rate from open Market.

Taxes and TDS:

Taxes and TDS will be deducted at the source as per the prevailing Government Rule.

GST:

GST as per the prevailing norms will be payable additionally by the BGSYS to the firm along with the bill amount.

The firm, on its part, will submit the relevant monthly challan/Log book/ duty slip for payment of GST to the BGSYS along with the Invoice.




Driver:

The firm/contractor shall provide dully licensed driver of the vehicles when used for the purpose of this agreement. The driver should be deemed to be the employee of the first party / firm/contractor but they shall obey orders and directions given to him by controlling office for the purpose of carrying out the services to be performed by the firm/contractor under this agreement. The driver provided shall have an unblemished record and should not have any past criminal records. The driver will be well behaved and neatly dressed. The driver must not be under intoxication while on duty.

Termination of the Contract:

Though this contract will normally be valid for a year or upto the closure of the project (whichever is earlier) (extendable further one year on mutual consent), this agreement may be prematurely terminated any time in between by either parties by giving the other party a written notice of two months.
